SOOGA/OOGA Region III & IV Meeting Update

May 30, 2019, Marietta, Ohio

1. New chair election - Steve Sigler re-elected as Chair through Spring 2020
Congratulations Steve.
2. Ohio 811
 - a. OOGA met with them, discussed concerns of excessive notifications, narrowing down scope of work by contractors, markers and getting all info needed to make markings.
 - b. Discussed completion and emergency tickets
 - c. Flat fee this year, and continuing through 2020 pending final vote of approval. 30 to 40 companies have not responded yet, will re-evaluate fees at the end of 2020.
 - d. Discussed issues about hold time when calling in, having form filled out with needed information prior to calling in, etc.
 - e. Remedies – expand or go to polygon system areas to catch all lines to/from wells, not doing so may create more tickets.
3. Mack Smith, Dominion – Heat Content Agreement updates
 - a. Reviewed history of HCA since 2003
 - b. Ludlow BTU for 2019 is 1351 BTU
 - c. Through 2019, 44 million invested. Oxygen issues, compression and pipe in ground issues.
 - d. Production volumes – High of 64 BCF annually since start of HCA, 2018 volumes were 31 BCF, mainly due to shale volumes and price differential to TCO.
 - e. Current production is 78 to 80 thousand per day, down from 144 day in 2008
 - f. \$.08 HCA fee for now.
 - g. PRC under spent total of \$6.6 million from 2008 through 2018
 - h. Extended HCA agreement to 10/20/2020
 - i. Suggestions for projects from producers – lines won't take gas, drilling opportunities (no lines), reducing pressures to enhance flow, production that does not flow year-round.

THE CROW'S NEST

It is that time of the year again. As we move from spring into summer, we are in the shoulder months for natural gas. Excess gas supply coupled with no real demand for heating or cooling has caused the price for natural gas to drop below \$2.30/MCF. We do not like it, but we are all familiar with it. Oil prices seem to be hovering in the \$50 to \$60/bbl. range depending on OPEC adjustments, trade discussions or Iran behavior. At least that is a tolerable range. This is the time of year we hunker down and grind it out.



Be sure to check out the article in this issue on the Regions 3 & 4 Producers Forum held in May. It is a good summary on the Ohio 811 (One Call) status and the new Dominion Heat Content Agreement. The ongoing conversation between SOOGA/OOGA and Ohio 811 will lead to improvements which will give relief on the volume of line locates operators are currently experiencing.

I want to give you an update on the Oxygen issue at the Aspire delivery point into Dominion at Ludlow Station. SOOGA has worked with Aspire in recent months to isolate and address the oxygen issue on their Elk System which flows to Ludlow. During that process, the conversation expanded to the Cobra pipeline system. There is an interconnect between the Cobra pipeline system and the Aspire Elk system. SOOGA and Aspire were able to make an arrangement with Cobra to activate the existing meter at that interconnect. The meter was activated and electronic measurement was installed. A volume of gas was turned on to test the installation. There were some startup issues with the electronic measurement. Just as those issues were addressed, Dominion's compressor at Ludlow went down. The compressor was down for a few days for repair. The compressor was brought on line and pressures on the pipeline system are stabilizing. Aspire has been monitoring oxygen levels at the Ludlow delivery point. The increase in gas volume through that meter has improved the oxygen situation.

Aspire had agreed to buy the gas from any operator on the Cobra pipeline system. SOOGA does not have a comprehensive list of operators on the Cobra system. If you have volumes currently shut in on the Cobra system, please contact the SOOGA office so we can compile a list. We can then forward the information to Aspire/Cobra so contracts can be executed and arrangements made to turn on wells. This collective effort is to get shut in wells flowing again. We will keep you updated.

Keep your head down and keep digging.

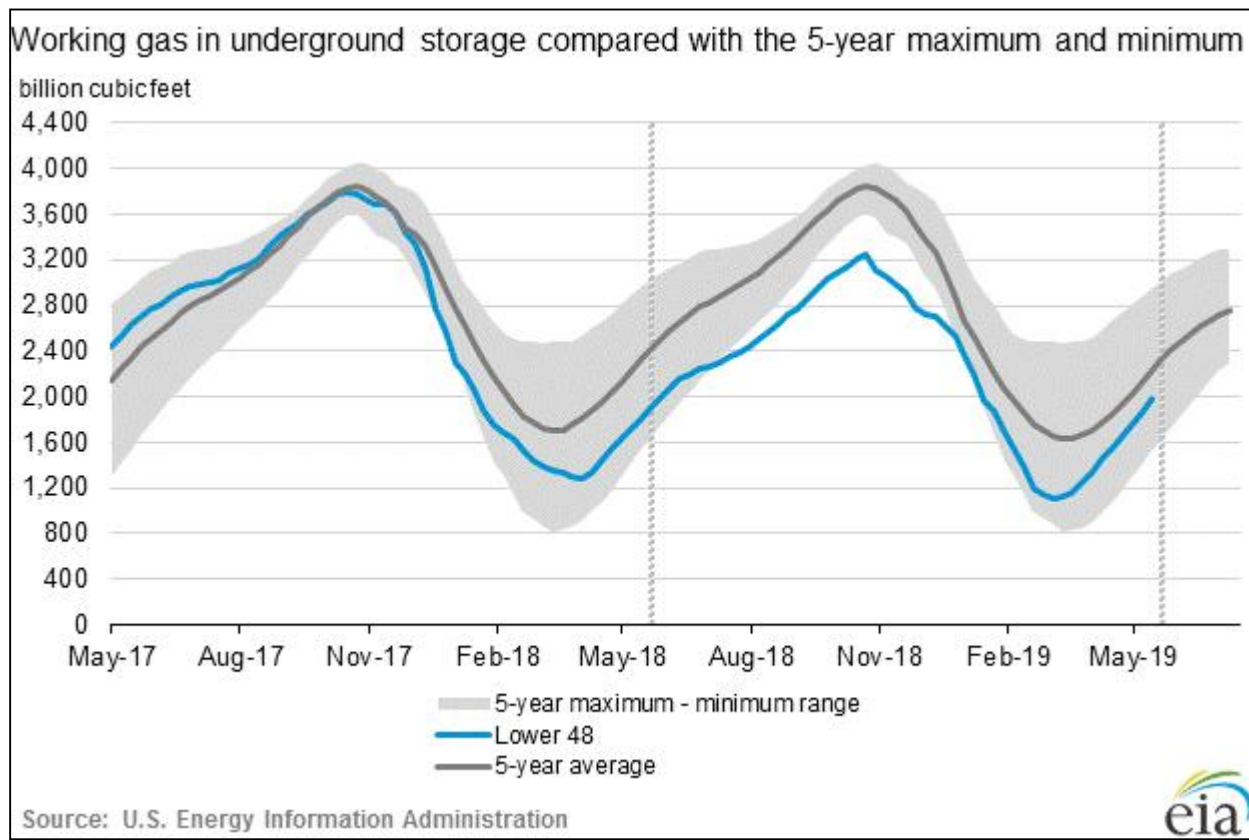

Summary

Working gas in storage was 1,986 Bcf as of Friday, May 31, 2019, according to EIA estimates. This represents a net increase of 119 Bcf from the previous week. Stocks were 182 Bcf higher than last year at this time and 240 Bcf below the five-year average of 2,226 Bcf. At 1,986 Bcf, total working gas is within the five-year historical range.

Natural Gas

Prices/Supply/Demand:

Northeastern prices fall. At the Algonquin Citygate, which serves Boston-area consumers, prices went down 2¢ from a high of \$2.32/MMBtu last Wednesday to \$2.30/MMBtu yesterday. At the Transcontinental Pipeline Zone 6 trading point for New York City, prices decreased 9¢ from a high of \$2.33/MMBtu last Wednesday to \$2.24/MMBtu yesterday.

Tennessee Zone 4 Marcellus spot prices decreased 17¢ from a high of \$2.19/MMBtu last Wednesday to \$2.02/MMBtu yesterday. Prices at Dominion South in southwest Pennsylvania fell 13¢ from \$2.21/MMBtu last Wednesday to \$2.08/MMBtu yesterday.

Supply is flat. According to data from PointLogic Energy, the average total supply of natural gas remained the same as in the previous report week, averaging 94.2 Bcf/d. Dry natural gas production decreased by 1% compared with the previous report week. Average net imports from Canada increased by 8% from last week.

Increased natural gas-fired power generation drives rising demand. Total U.S. consumption of natural gas rose by 4% compared with the previous report week, according to data from PointLogic Energy. Natural gas consumed for power generation climbed by 10% week over week. Industrial sector consumption increased by 2% week over week. In the residential and commercial sectors, consumption declined by 11%. Natural gas exports to Mexico increased by 1%.

U.S. LNG exports decrease week over week. Eight LNG vessels (six from Sabine Pass, one from Cove Point, and one from Cameron) with a combined LNG-carrying capacity of 33.4 Bcf departed the United States from May 30 to June 5, according to shipping data compiled by Bloomberg. One vessel was loading at the Sabine Pass terminal on Wednesday.

Cheniere Energy—the developer of the Sabine Pass and Corpus Christi liquefaction terminals in Louisiana and Texas—**announced** on Monday that the company made a Final Investment Decision to proceed with the development of Sabine Pass Train 6. Currently, Sabine Pass has five trains in operation, with a combined base load LNG-production capacity of 2.96 Bcf/d (3.45 Bcf/d peak capacity). Train 6 has a full set of regulatory approvals and will have a 0.59 Bcf/d base load LNG-production capacity.

Ohio's Utica Shale 2019 First Quarter Production

During the first quarter of 2019, Ohio’s horizontal shale wells produced 5,073,536 barrels of oil and 609,452,391 Mcf (609 billion cubic feet) of natural gas, according to figures released today by the Ohio Department of Natural Resources (ODNR).

Natural gas production from the first quarter of 2019 showed a 8.15% decrease over the fourth quarter of 2018, while oil production decreased 12.7% for the same period.

As of June 3, 2019, there have been 3,105 Utica shale permits issues in Ohio, and 2,613 of them have been developed.

There are currently 2,278 Utica shale wells in production, with 19 rigs running.



4. 5 Year Rule review
 - a. Well spacing and construction review
 - b. UIC discussions
 - c. 77 different rules plus some new ones under review

W.Va. Court: Drilling rights are for minerals directly below

CHARLESTON, W.Va. (AP) - The West Virginia Supreme Court has affirmed a lower court's ruling in favor of landowners' claims that a company had no right to drill on their property to access oil and gas on other lands.

The court's ruling released Wednesday said a mineral owner has the right to access only what's directly below the surface. The court's said "it is trespassing to go on someone's land without the right to do so."

A Doddridge County Circuit Court jury in 2017 awarded \$180,000 to David Wentz and \$10,000 to his ex-wife, Margot Beth Crowder, in their lawsuit against EQT Production.

The company held a century-old lease allowing it to drill wells to extract oil and gas from beneath the plaintiff's land. The plaintiffs sued to challenge the company's use of their land to drill horizontal wells extending to neighboring properties.

HEAT STRESS PREVENTION



As spring turns into summer and brings up “hot weather”, we should all be aware of some tips to prevent heat stress. Remember physical activity at high temperatures can directly affect health and indirectly be the cause of accidents.



What is Heat Stress?

It's a signal that says the body is having difficulty maintaining its narrow temperature range. - ◆ Drinking water frequently and moderately (every 15-30 minutes-about a glassful). Due to the fact that most of us already consume excessive salt in our diets, salt tablets are NOT recommended for general use.
- ◆ Resting frequently.
- ◆ Eating lightly.
- ◆ Doing more strenuous jobs during the cooler morning hours.
- ◆ Utilizing the ventilation or fans in enclosed areas.
- ◆ Remembering that it takes about 1-2 weeks for the body to adjust to the heat; this adaptation to heat is quickly lost—so your body will need time to adjust after a vacation too.
- ◆ Avoiding alcohol consumption. Many cases of heat stroke have occurred the day after a “night on the town”.
- ◆ Wearing light colored, cotton clothes and keeping your shirt on, desert nomads don't wear all those clothes for nothing.



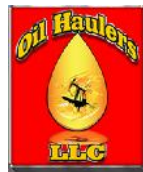
