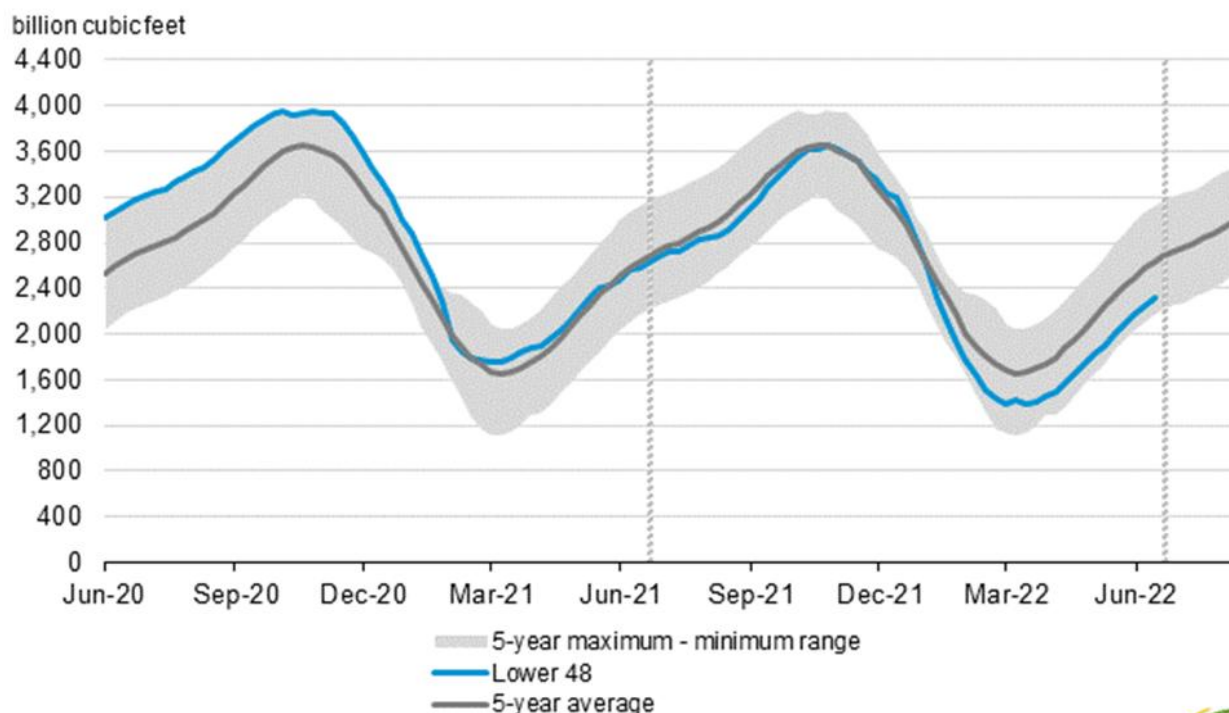

Summary

Working gas in storage was 2,457 Bcf as of Friday, July 29, 2022, according to EIA estimates. This represents a net increase of 41 Bcf from the previous week. Stocks were 268 Bcf less than last year at this time and 337 Bcf below the five-year average of 2,794 Bcf. At 2,457 Bcf, total working gas is within the five-year historical range.

**Prices/Supply/Demand**

Supply: According to data from PointLogic, the average total supply of natural gas rose by 0.5% (0.5 Bcf/d) compared with the previous report week. Dry natural gas production grew by 0.9% (0.9 Bcf/d), and average net imports from Canada decreased by 6.2% (0.4 Bcf/d) from last week.

Demand: Total U.S. consumption of natural gas fell by 1.8% (1.3 Bcf/d) compared with the previous report week, according to data from PointLogic. [Temperatures](#) that were closer to normal in most of the United States resulted in lower demand for air conditioning. Natural gas consumed for power generation declined by 2.7% (1.2 Bcf/d) week over week, and consumption in the residential and commercial sectors declined by 3.3% (0.3 Bcf/d). Industrial sector consumption increased by 0.7% (0.1 Bcf/d) week over week. Natural gas exports to Mexico decreased 8.8% (0.5 Bcf/d). Natural gas deliveries to U.S. LNG export facilities (LNG pipeline receipts) averaged 10.9 Bcf/d, or 0.1 Bcf/d higher than last week.

In the Northeast, at the Algonquin Citygate, which serves [Boston-area consumers](#), the spot price increased 22 cents from \$8.31/MMBtu last Wednesday to \$8.53/MMBtu yesterday. Algonquin Citygate prices traded below \$8.00/MMBtu on most days this report week, reaching a low of \$7.78/MMBtu on Thursday. At the Transco Zone 6 NY trading point for New York City, the price increased 3 cents from \$8.08/MMBtu last Wednesday to \$8.11/MMBtu yesterday, but on every other day of the report week it was below \$8.00/MMBtu, reaching a low of \$7.41/MMBtu on Tuesday. Temperatures in the [Boston Area](#) averaged 79°F this week, 4°F above normal but 3°F below last report week's average, while in the [New York Central Park Area](#), temperatures averaged 79°F this week, 3°F less than last week. Temperatures have been rising in recent days and are expected to increase further above normal in the Northeast through the weekend and into early next week.

LNG

- **Pipeline receipts:** Natural gas deliveries to LNG export terminals in South Louisiana increased by 2% (0.2 Bcf/d) this report week, according to data from PointLogic. Overall, feedgas deliveries to U.S. terminals increased by 0.1 Bcf/d (1%) week over week.
- **Vessels departing U.S. ports:** Twenty-two LNG vessels (eight from Sabine Pass, four each from Calcasieu Pass and Corpus Christi, three from Cameron, two from Cove Point, and one from Elba Island) with a combined LNG-carrying capacity of 81 Bcf departed the United States between July 28 and August 3 according to shipping data provided by Bloomberg Finance, L.P.

LNG export terminals: Calcasieu Pass received [approval](#) from the Federal Energy Regulatory Commission (FERC) to place Blocks 5 and 6 in service, indicating that the commissioning phase for these blocks is complete and that they are now in commercial service. Freeport LNG issued a [notice](#) yesterday that it now expects to resume initial operations at its Freeport LNG terminal in early October, enabling it to produce approximately 2 Bcf/d of LNG.

OOGEEP Educational Programming Reaches 2,400 Students In 2022 And Counting

The Ohio Oil and Gas Energy Education Program's efforts to reach students and teachers are critical to getting information where we need it the most – the classroom. We're proud to have reached over 2,400 students so far in 2022 and excited to see that number continue to grow in the final months of the year.

OOGEEP offers several educational programs targeting students and teachers, the largest of which is our teacher workshop program. Through this program, we offer educators teaching grades K-12 the opportunity to earn free continuing education units through our geology and STEM workshops. These workshops are designed to connect classroom learning to real world applications in the natural gas and oil industry and are accompanied by field trips to industry sites such as natural gas-fired power plants and well pads. This year we had 59 teachers from 25 counties participate in our workshops. Each of these educators will take the lessons they learned at our workshops this summer back to their students for the 2022-2023 school year. Collectively they will share these lessons with 5,330+ students in the coming months.

We also offer teachers the opportunity to have an OOGEEP staff member or industry professional present to their classroom. So far in 2022 this program has reached 2,397 students from 26 different schools in 19 Ohio counties. Classroom presentations are a great opportunity to show students the myriad of careers available to them in the natural gas and oil industry regardless of education level. If you know a teacher interested in scheduling a classroom presentation for the 2022-2023 school year, or would like to volunteer as a classroom speaker, contact Shawn Toy at stoy@oogEEP.org for more information.

In addition to our classroom programming, we offer students the opportunity to compete for the Ohio Oil and Gas Energy Education Program Award at the State Science Day. While there are only two winners, dozens of students from around the state compete for the award which promotes science projects related to the industry. This year, Owen Crabtree of Toledo and Amelia O'Meara-Hill of Gambier won first and second place respectively.

Beyond our programming focused on students in grades K-12, we also offer a scholarship program for students attending vocational school or pursuing 2- and 4-year degrees. Scholarship winners must be an Ohio resident or attending an Ohio school and must have a demonstrated interest in working in the natural gas and oil industry upon program completion. This year we hosted our inaugural Ohio Energy Student Scholarship Breakfast at Ariel Corporation's Training Facility, where we awarded 32 students with \$32,000 worth of scholarships. Operating these programs, as important as they are, is no small feat, and we couldn't do it without the generous support of Ohio's natural gas and oil producers. Audit finds Ohio orphan well program falls short

Ohio's program to plug abandoned oil and gas wells has been chronically underachieving, according to a new state audit.

While the ODNR's Division of Oil and Gas Resources drastically increased the number of wells plugged each year — from 10 in 2013 to 202 in 2021 — it failed each year to reach the spending requirements set by the state. The Ohio Department of Natural Resource's Orphan Well Program is required by state law to use 30% of annual collections from the state's oil and gas severance tax, a goal that has never been met. To hit the 30% mark, the department would have to double its staff. That's what was reported in a new performance [audit](#) of the program released

Aug. 9, by the Ohio state auditor. The program also lacks data on many of the abandoned wells believed to be in the state, according to the audit. There are an estimated 36,000 to 66,000 orphan wells, or abandoned wells without a legal owner. The department has 970 wells in its official orphan well inventory and many of those may lack accurate location and environmental data, according to the audit. "ODNR's Orphan Well Program is moving in the right direction, but there's still much work to do," said Auditor of State Keith Faber, in a statement. "We need to pick up the pace."

Compounding problems

The orphan well program was created in 1977 to address the thousands of wells abandoned before modern oil and gas regulations were put in place.

About 175,000 oil and gas wells were drilled in Ohio, from the 1860s to the creation of the Division of Oil and Gas Resources in 1965. It was common practice during this time to abandon wells once they ran dry. That left a lot of environmental and safety hazards scattered around the Ohio countryside. Orphan wells can leak oil or gas into the surrounding air, oil and groundwater.

The audit found the department needs to put more wells out to bid, hire more contractors and improve data collection and staffing for the program.

Last year was the program's best year for plugging wells, spending \$11.2 million to plug more than 200 wells, but it still only hit 14.9% of its spending allotment. To meet the 30% target, the division should have plugged 373 wells and spent \$22.5 million, according to the audit.

The division has a bank of 44 approved contractors, but only 20 plugged an orphan well last year.

"On average, a well plugging crew can plug a single well in about 10 business days, so any given contractor can be expected to be able to plug about 24 wells per year," the report stated. "Hypothetically, this means that the 44 approved contractors could be able to plug around 1,000 wells per year."

The division uses its employees for the vast amount of orphan well pre-work to get wells ready to go to bid. It takes about 300 hours of staff work to prep and oversee the well plugging process for one well, according to the ODNR. In 2021, that amounted to more than \$3 million.

The ODNR interprets the state law to mean that only plugging contracts counts towards the 30% spending requirement, meaning internal staff work on the program doesn't count toward the goal. Including that \$3 million would only have brought the program's spending up to 19%, still short of the goal, the audit found.

Spending Issues

Another problem the program faced in meeting its spending goal was, paradoxically, the success of the industry, which pumped an enormous amount of money into the program's coffers in the last decade.

Severance tax revenue increased by over 1,000% during the shale gas boom, from \$7.2 million in 2012 to \$81 million in 2019 at the peak of the state's natural gas production. This meant that each year more money was available to the program that was already not hitting its spending goals.

Then in 2018, a state law gave the orphan well program a bump in state funding, increasing the amount earmarked for the program from 14% to 30% of the state's oil and gas severance tax. While this was good for boosting the program's productivity — more staff was hired and more contractors were secured — it also moved the spending target that the division was already having trouble meeting.

The department is restricted in how it can use severance tax money so the unspent money continues to pile up. There is more than \$180 million sitting in the oil and gas well fund that can only be used by the division, according to the audit.

Response

ODNR director Mary Mertz said in the letter responding to the audit that the department has had difficulty finding contractors.

She said the department awarded the entirety of the set-aside funding for plugging wells for 2022, but gave no explanation for why it had failed to plug enough wells for years.

Earlier this year, the division [announced](#) efforts to grow its orphan well program, thanks in part to a boost in funding from the federal infrastructure bill passed late last year. An estimated \$326 million in federal funds will be available to Ohio through 2035.

With the federal funding available, the division planned to hire more contractors and consultants to help with all parts of the plugging process, including flying drones to locate wells, designing plugging plans, overseeing construction and plugging the wells. A public information campaign was also launched to get residents to report orphan wells to the division. Mertz also said they worked with the General Assembly in the spring to change state law to include all direct costs involved with plugging a well to be charged to the spending requirement.

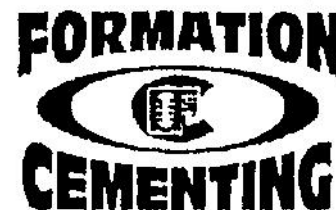

SPRAINS AND STRAINS

Sprains and Strains, most often involving the back, accounted for 43% of the 1.3 million injuries and illnesses in private industry. Most cases occur in construction, transportation, and general industry.

Employers need to train workers so they can safely perform lifting tasks. Engineering controls attempt to redesign a job so lifting becomes less hazardous.

Suggested administrative controls include:

1. Training employees to utilize lifting techniques that place minimal stress on the lower back.
2. Physical conditioning or stretching programs to reduce the risk of muscle strain.

Suggested engineering controls include:

1. **A reduction in the size or weight of the object lifted.** The parameters include maximum allowable weights for a given set of tasks requirements; the compactness of a package; the presence of handles, and the stability of the package being handled.
2. **Adjusting the height of a pallet or shelf.** Lifting which occurs below knee height or above shoulder height is more strenuous than lifting between these limits. Obstructions which prevent an employee's body contact with the object being lifted also generally increase the risk of injury.
3. **Installation of mechanical aids** such as pneumatic lifts, conveyors, and/or automated materials handling equipment.

Other Factors:

Frequency of lifting, duration of lifting activities, and type of lifting, as well as individual variables such as age, sex, body size, state of health, and general physical fitness.



Proper Lifting:

1. Plan your move:
 - Size up the load and make sure your path is clear.
 - Get help as needed.
 - Use a dolly or other materials handling equipment if possible.
2. Use a wide, balanced stance with one foot slightly ahead of the other.
3. Get as close to the load as possible.
4. Tighten your stomach muscles as the lift begins.
5. When lifting, keep your lower back in its normal arched position and use your legs to lift.

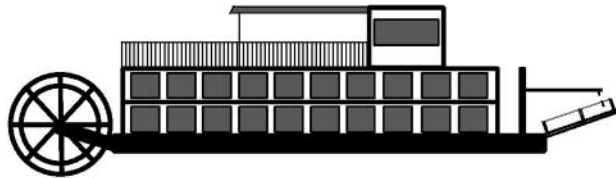
