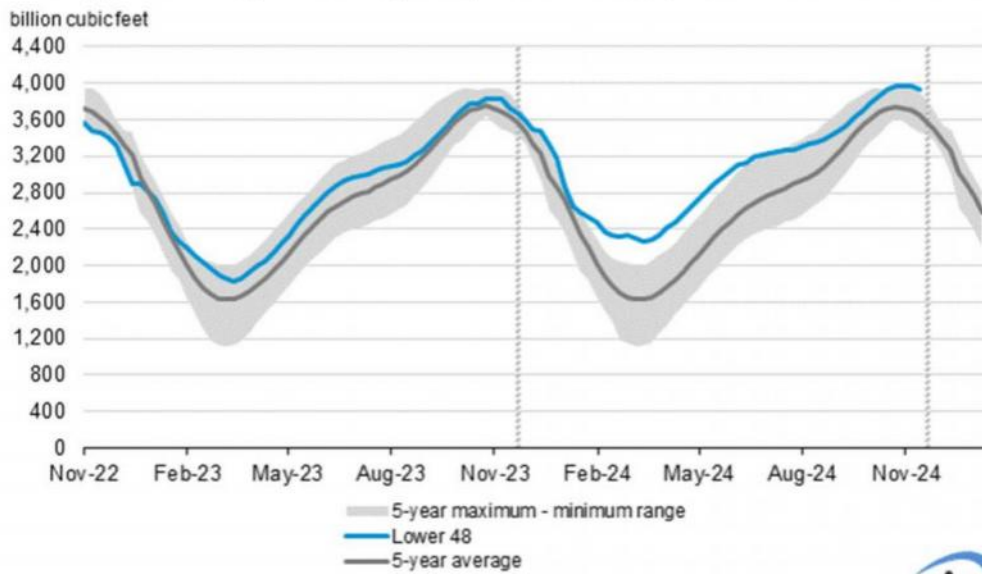

Summary

Working gas in storage was 3,937 Bcf as of Friday, November 29, 2024, according to EIA estimates. This represents a net decrease of 30 Bcf from the previous week. Stocks were 185 Bcf higher than last year at this time and 284 Bcf above the five-year average of 3,653 Bcf. At 3,937 Bcf, total working gas is above the five-year historical range.

Prices/Supply/Demand

- **Supply:** According to data from S&P Global Commodity Insights, the average total supply of natural gas rose by 0.1% (0.2 Bcf/d) compared with the previous report week. Dry natural gas production decreased by 0.3% (0.3 Bcf/d) to average 103.0 Bcf/d, and average net imports from Canada increased by 7.0% (0.4 Bcf/d) from last week.
- **Demand:** Total U.S. consumption of natural gas rose by 19.3% (17.4 Bcf/d) compared with the previous report week, according to data from S&P Global Commodity Insights. Natural gas consumed in the residential and commercial sector increased by 41.1% (13.2 Bcf/d) week over week as average temperatures across most of the country were lower than normal. Natural gas consumed for power generation increased by 9.4% (3.1 Bcf/d), and consumption in the industrial sector increased by 4.4% (1.1 Bcf/d). Natural gas exports to Mexico increased 0.5% (less

than 0.1 Bcf/d). Natural gas deliveries to U.S. LNG export facilities (LNG pipeline receipts) averaged 14.5 Bcf/d, or 0.5 Bcf/d higher than last week.

Pricing:

- **Henry Hub spot price:** The Henry Hub spot price fell 52 cents from \$3.35 per million British thermal units (MMBtu) last Wednesday to \$2.83/MMBtu yesterday.
- **Henry Hub futures price:** The December 2024 contract expired on Tuesday, November 26, at \$3.431/MMBtu. The price of the January 2025 NYMEX contract decreased 16 cents, from \$3.204/MMBtu last Wednesday to \$3.043/MMBtu yesterday. The price of the 12-month strip averaging January 2025 through December 2025 futures contracts declined 8 cents to \$3.161/MMBtu.
- **Select regional spot prices:** Natural gas spot prices fell at most locations this report week (Wednesday, November 27 to Wednesday, December 4). Price changes ranged from a decrease of 52 cents at the Henry Hub to an increase of 68 cents at Northwest Sumas.
 - Price changes were mixed in the Northeast this report week. At the Algonquin Citygate, which serves [Boston-area consumers](#), the price rose 22 cents from \$9.82/MMBtu last Wednesday to \$10.04/MMBtu yesterday. At the Transco Zone 6 NY trading point for New York City, the price decreased 38 cents from \$3.68/MMBtu last Wednesday to \$3.30/MMBtu yesterday. Temperatures in the [Boston Area](#) averaged 36°F this report week, which resulted in 199 heating [degree days](#) (HDDs), 60 more HDDs than the previous report week and 23 more HDDs than normal. Natural gas consumption in the Northeast increased by 28% (6.5 billion cubic feet per day [Bcf/d]), according to data from S&P Global Commodity Insights, led by a 46% (5.1 Bcf/d) increase in consumption in the residential and commercial sector to meet space heating demand. Natural gas flows from Appalachia to the New York and New Jersey area increased by 19% (1.6 Bcf/d) from the previous report week.

2025 Price Estimates:

EIA expects the Average price of natural gas to be \$2.80 in 2025.



HOPE GAS ABANDONMENT

December 20, 2024

To whom it may Concern;

On behalf of our members with Southeastern Ohio Oil and Gas Association we are writing to express serious concerns about Hope Gas's recent filing with the West Virginia Public Service Commission (WV PSC) to abandon approximately 500 natural gas customers and 1,068 miles of pipeline, known as Red Lines. This proposal has far-reaching implications for our communities, small producers, and the economic stability of rural areas in West Virginia.

Hope Gas's plan involves converting nearly 500 gas customers to propane, with the company covering the conversion costs. However, during recent town hall meetings, it became evident that many customers oppose this change. Additionally, Hope Gas intends to transfer ownership of the 1,068 miles of pipeline to oil and gas producers who currently supply gas to these lines. This raises significant concerns for several free gas customers who depend on these lines under agreements granting pipeline rights of way. One such customer noted at a town hall meeting that their free gas agreement, tied to a pipeline right of way, may be jeopardized if producers take over these lines without a right of way in place. Thousands of oil and gas wells feed into the Red Lines, operated by hundreds of small producers. Many of these producers are landowners with a few wells providing free gas for their properties, while others manage dozens or even hundreds of wells. These wells, though low in volume, are essential to providing gas to homes, generating income for royalty owners, and contributing significant tax revenue to the state of West Virginia and local communities. Abandoning the Red Lines would force the plugging of thousands of these wells, costing millions of dollars to producers and the state.

Small producers lack the resources and expertise to take over and manage these pipelines. For years, they have paid millions of dollars in gathering and processing fees, only to see previous pipeline owners fail to maintain the infrastructure adequately. To ask these producers to assume responsibility for this aging network at this stage of the wells' lifecycle would be detrimental to their operations and unsustainable for the industry. Furthermore, the short timeframe Hope Gas has requested for this transition makes it nearly impossible to develop viable solutions to address the complex issues involved. Abandoning these pipelines affects not only current producers, customers, and free gas users but also the future development of rural areas served by these lines. These lines are vital to approximately 18 counties in the state, and their loss would have long-lasting economic consequences.

We would greatly appreciate if you would intervene on behalf of the affected constituents and communities. Please advocate for a more comprehensive and equitable solution that considers the needs of small producers, customers, and free gas users while ensuring the continued viability of the natural gas infrastructure that supports rural West Virginia. Thank you for your attention to this critical issue.

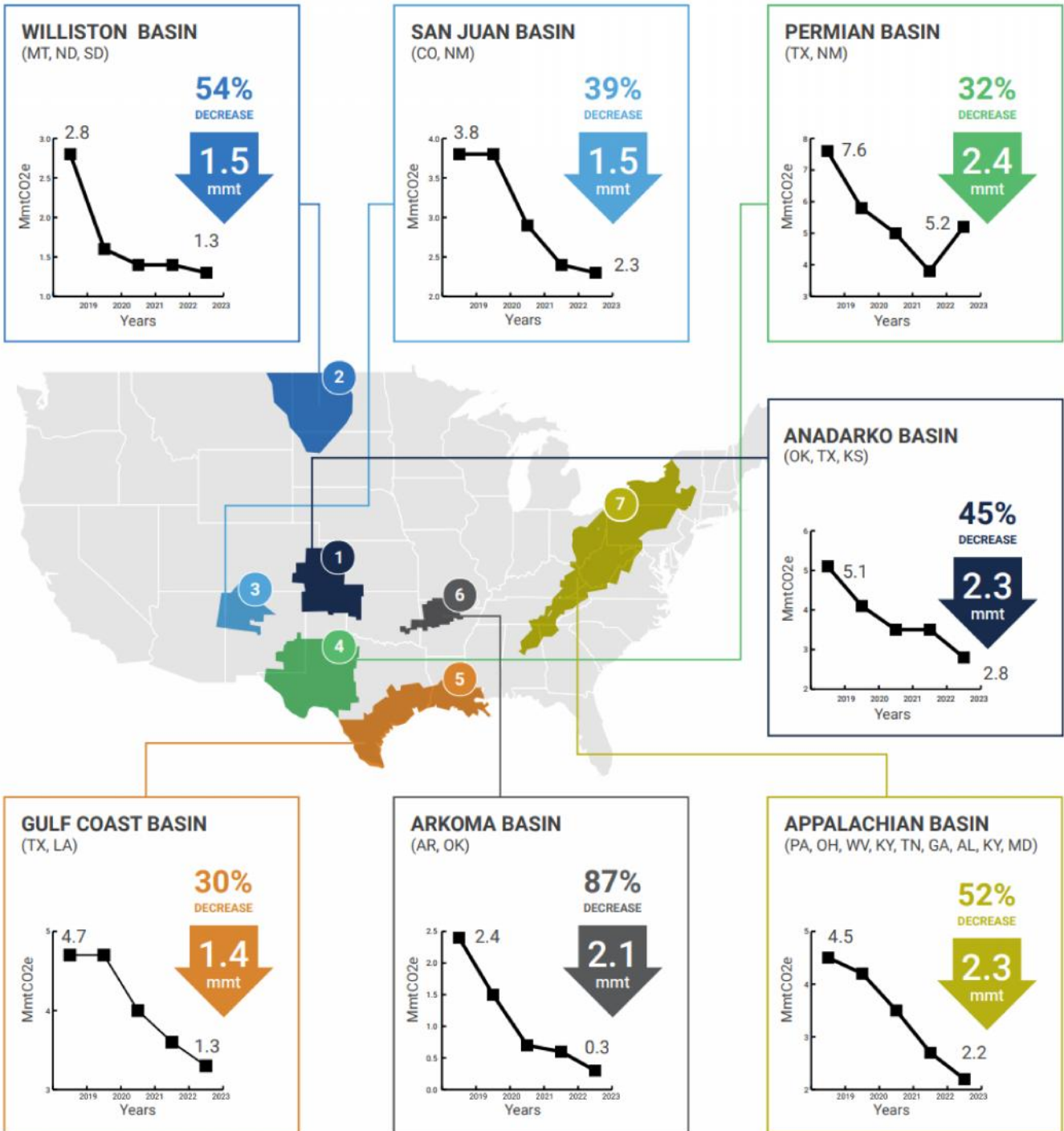

Methane Emissions Decline in Top Oil and Gas Basins (2019-2023)



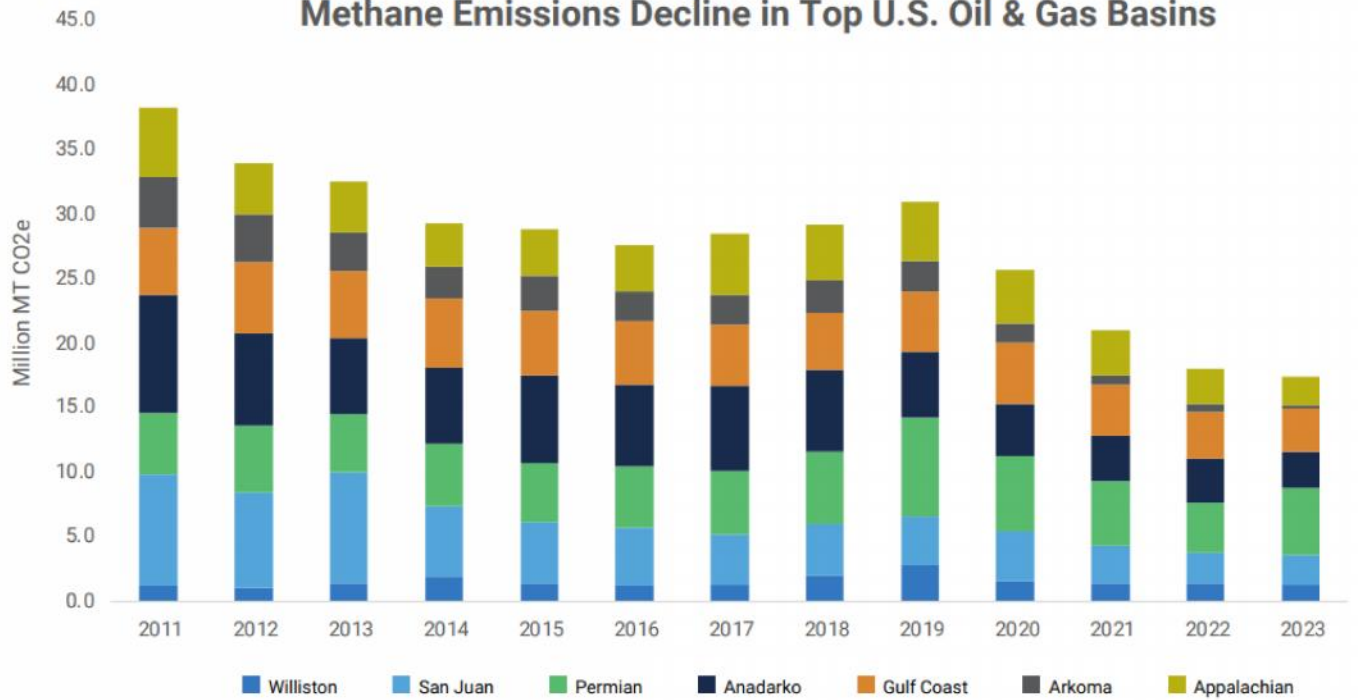

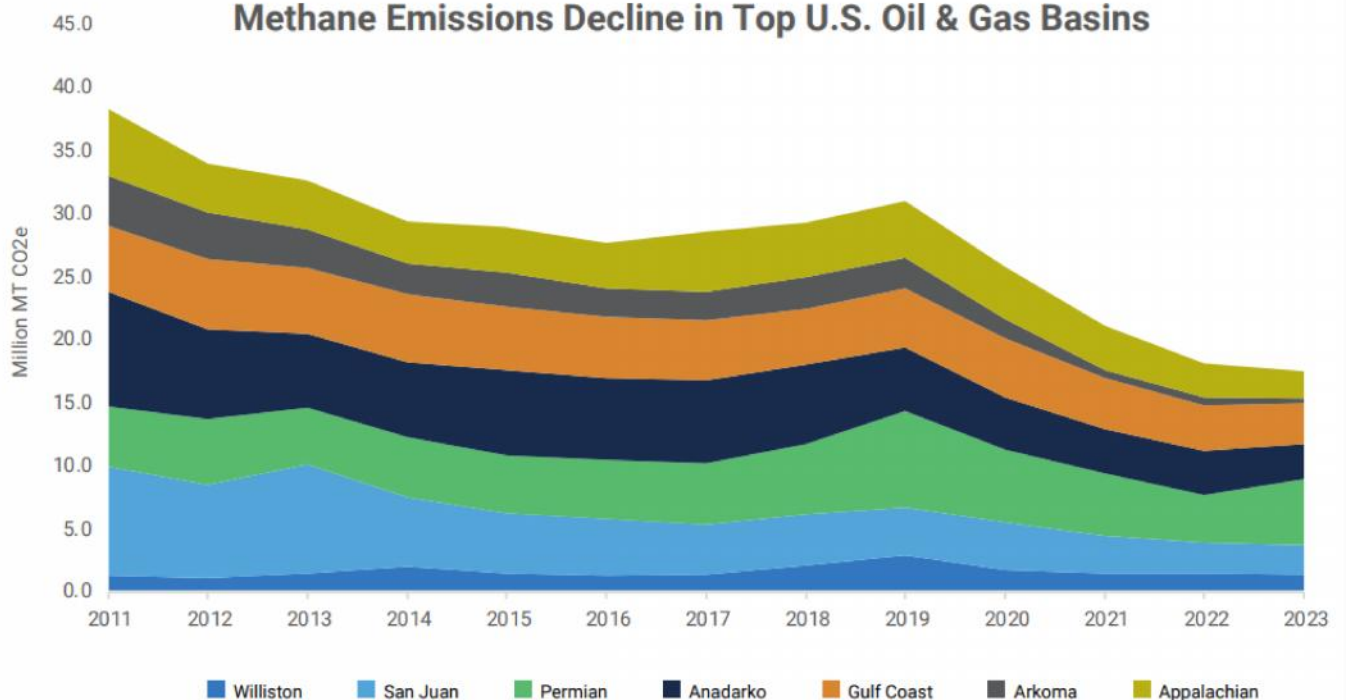

OBITUARIES

**Sarah J. Tipka. 23 April, 1945- December 16, 2024**

Sarah J. Fosbrink Tipka was born April 23, 1945 to Dr. E. L. Fosbrink and Mary Elizabeth Humpke Fosbrink. The Fosbrink family valued education, integrity, and community service, values which Sarah embodied throughout her life.

A woman of boundless energy and enthusiasm, Sarah managed to fit not one, but two, successful careers into one lifetime. After earning a BA from Purdue University in 1967 and an MA from Michigan State University in 1968, she began 21 years of service as an elementary school teacher. During this time, she was presi-

dent of the Pike Classroom Teachers' Association (Pike Township Schools, Indianapolis, Indiana) and served on the local classroom teachers' collective bargaining committee.

In 1984 Sarah was hired by William N. Tipka, an independent oil and gas producer in Ohio, to work part time during her summer vacation as a leasing agent. This summer job turned her life in more than one new direction. She joined the Ohio Oil and Gas Association (OOGA) in 1985 and Desk and Derrick in 1988. In 1989 Sarah married her longtime friend, William's son Alan W. Tipka.

Sarah became a member of OOGA's Public Relations Committee in 1995 and was appointed a charter member of the Ohio Oil and Gas Energy Education Program Board in 1998. In 2007 Sarah received the OOGA Patriot Award; she was inducted into the OOGA Hall of Fame in 2011.

The accolades for Sarah's outstanding contributions to the oil and gas industry continued to pour in. She received the Lifetime Achievement Award from the Southeastern Ohio Oil & Gas Association in 2017. In 2019 Sarah was honored with the Ohio Oil and Gas Energy Education Program Legacy Award. The Ohio Natural Energy Institute's Inaugural Sarah J. Tipka Excellence in Energy Education Award, instituted in 2024, represents the capstone of a stellar career and embodies the enduring legacy of Sarah's professional accomplishments.

Sarah Tipka was much more than her professional accomplishments. She always gave unstintingly of herself to her family and friends. Her laugh brought the sun out on a rainy day. Her hugs could mend a broken heart. Sarah was not only an educator, but also a physician, a healer. Her death diminishes everyone who knew and loved her.

Sarah is survived by her husband, Alan W. Tipka; stepdaughters Gwen Jones (Christa) and Laura Tipka; sister Susan West (David); and an extensive extended family.

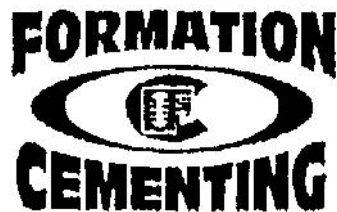
